- ! Form 410 from Secretary of State's Office to secure Campaign ID number
- ! Bank account with Campaign ID number
- ! Treasurer trusted to handle money and relevant FPPC filings
- ! Calendar with key dates and deadlines (see below)
- ! Resources specifically for women interested in running (see below)
- ! Positive attitude

Must-Do Items:

- ! Check your personal voter registration status be certain it accurately reflects your current party affiliation, spelling of your name, home address, etc.
- ! Check the qualifications and duties of the office you are seeking.
- ! Enlist friends/family to help secure signatures for your filing papers.
- ! Meet all the deadlines see "Election Timeline" below.
- ! Make sure you file on time and submit the appropriate filing fee.

Notes:

If you're running for a non-partisan office, you may include a Candidate Statement of Qualifications, which is included in the Sample Ballot Booklet sent to every registered voter in the county. The Candidate Statement is an extra cost, but it will serve you well as a lot of people rely on the booklet, especially for minor offices. However, it is optional and not a requirement for filing.

Local Offices Up on June 5

- 1. In races with only two candidates, the top vote earner wins the seat outright.
- 2. In races with more than two candidates, the candidate who earns 50 percent plus one vote wins.
- 3. If no candidate wins 50 percent plus one, the top two candidates run off in the November general election.

An employee of a school district may not be sworn into office as an elected or appointed member of the district's governing board unless and until s/he resigns as an employee.

<u>Community College District Trustees</u>: Shall be a Registered Voter and Resident of the District and Trustee Area. An employee of a community college district may not be sworn into office as an elected or appointed member of the district's governing board unless and until s/he resigns as an employee. No member of the governing board shall during the term be eligible to serve on the governing board of a high school district whose boundaries are coterminous with those of the college district.

Fire Protection Districts: Shall be a Registered Voter of the District

<u>Harbor Districts:</u> Shall be a Registered Voter of the District and shall secure a nomination paper signed by not less than 25 but not more than 50 registered voters of the District. Upon taking the Oath of Office shall file a \$5,000 bond with the elections official, subject to the approval of the Board of Supervisors.

Make an appointment with the Elections Division of the County Clerk's Office, County Government Center, SLO, to make sure all your information is correct and appears on the ballot the way you want it.

SETTING CANDIDATE APPOINTMENT

Prospective candidates must schedule a nomination appointment during the nomination period.

In order to make candidate appointments efficient for everyone, candidates **must** call the office at 805-781-5228 ahead of time to answer the following questions: Candidates will then be emailed a packet of forms to be completed and presented at their first appointment.
